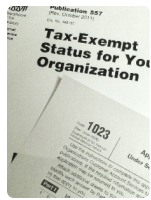

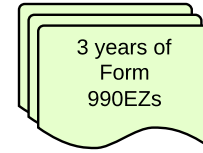


Pay IRS fee of \$400 or \$850
